The Maricopa County Adult Probation Department's caseload ratios were last evaluated and affirmed by the Department's Funding Authority, the Maricopa County Board of Supervisors, in 2019. The Department services the fourth largest Trial Court in the United States and in addition to the caseloads below, officers and staff further support the Court through the Department's initial appearance and presentence units.

Pretrial Supervision

Caseload	Ratio	Description
General Pretrial	75:1	These caseloads are designed to support someone's continued appearance in Court and in remaining crime free while out on release and under supervision.
Electronic Monitoring	25:1	These caseloads employ the use of a GPS device to enhance supervision of those who are typically higher risk as ordered by the Court.

Probation Supervision

Caseload	Ratio	Description
Standard Probation	60:1	This is the Department's largest population and also includes within it Veteran's Court and Interstate Compact Incoming caseloads.
Seriously Mentally Ill	40:1	This caseload provides specialized supervision and treatment to individuals who have an SMI determination through the Regional Behavioral Health Authority. They focus on those who are higher risk, higher needs, and experiencing crisis.
Drug Court	40:1	This program offers cognitive-based, intensive outpatient substance use counseling and drug monitoring for high risk and high need participants with substance use disorders.
DUI Court	40:1	This program is a problem-solving court based on the Drug Court model. A multi-disciplinary team works together to address offenses involving driving and substance use.
Supervised Youth	40:1	This program supervises juveniles sentenced to probation in adult court and individuals up to the age of twenty-one. It includes probation officers and a clinical coordinator as well as therapeutic court.
Sex Offender	60:2	To supervise this population, a two-person team consisting of a probation officer and a surveillance officer is utilized. Specialized training is also provided to the staff managing this population.
Domestic Violence	60:2	To supervise this population, a two-person team consisting of a probation officer and a surveillance officer is utilized. Specialized training is also provided to the staff managing this population.
Intensive Probation	15:1	Intensive probation in Arizona is reserved for only those who are assessed by the risk instrument as high risk.

Minimum Assessed Risk	350:2	These individuals, who are assessed by the risk instrument as minimum risk, are supervised by a two-person team consisting of a probation officer and a caseload administrator. These staff collaborate with standard field units to facilitate a seamless transition allowing standard field officers to focus their time on supervising higher-risk individuals.
Unsupervised Probation	500:2	These individuals are supervised by a probation officer and a caseload administrator who work as a team to achieve compliance. Individuals are provided the necessary resources to be successful at their initial intake and teams spend a considerable amount of time working restitution cases, contacting victims, and working with individuals to gain financial compliance.

Individuals in Custody

Caseload	Ratio	Description
Prison Reentry	20:1	These units supervise individuals released from the Arizona Department of Corrections Rehabilitation and Reentry. The goal of the program is to provide needs assessment, planning, and immediate interventions to ease the transition between prison and probation.
Custody Reintegration Unit (Standard)	75:1	The unit supervises individuals in the Maricopa County jail system for sixty days or more. Officers provide pre- and post-release services including comprehensive reentry planning, support, and interventions to help high-risk individuals smoothly transition from jail to the community.
